IN ORDER TO ASSURE THAT YOU WILL ENJOY YOUR VISIT, WE ASK THAT YOU COOPERATE BY PROVIDING US WITH THE FOLLOWING NECESSARY INFORMATION.

PLEASE ADVISE YOUR INTERVIEWER OF ANY PHYSICAL OR MEDICAL CONDITION THAT YOU HAVE THAT WE MUST BE MADE AWARE OF TO ASSURE YOUR SAFETY AND WELL BEING.

PLEASE ADVISE YOUR INTERVIEWER IF YOU HAVE ANY KNOWN ALLERGIES TO FOOD(S) AND / OR FOOD INTERACTIONS WITH MEDICATIONS. BE ADVISED THAT PRIOR TO YOUR OFFICIAL ENTRY INTO THE PROGRAM YOU WILL BE PLACED ON OUR CENTER REGULAR DIET WHICH IS MODERATELY LOW FAT, LOW CHOLESTEROL, AND LOW SODIUM. AFTER YOUR OFFICIAL ADMISSION, OUR CONSULTANT DIETITIAN WILL EVALUATE YOUR DIETARY STATUS AND WORK WITH YOUR PRIMARY DOCTOR ON THE MOST APPROPRIATE DIET FOR YOU TO FOLLOW WHILE YOU ARE AT THE CENTER.

PLEASE BRING WITH YOU ANY BOTTLES CONTAINING ALL PRESCRIPTION MEDICATIONS THAT YOU ARE TAKING AS ORDERED BY YOUR FAMILY DOCTOR. PLEASE BRING WITH YOU ANY BOTTLES OF MEDICATIONS THAT YOU ARE TAKING THAT YOU BUY FROM YOUR LOCAL PHARMACY.

PLEASE BRING WITH YOU MEDICAID AND MEDICARE ELIGIBILITY CARDS
